I am writing to inform you that the Wheels of Wayne Car Show & Community Event will return to the Radnor Township community this spring, specifically along North Wayne Avenue and part of West Avenue on Sunday, April 24, 2016 (Rain Date is Sunday, May 1, 2016) from 1:00 to 4:00 PM. The Radnor Township Recreation and Community Programming Department, along with the Wayne Business Association, have teamed again up to deliver *Wheels of Wayne*, a car and motorcycle show and free community event in downtown Wayne. Last year, *Wheels of Wayne* was an enormous success with over 4,000 people in attendance. The event has evolved into a new spring tradition that features a family-friendly atmosphere with an exquisite display of cars, trucks, and motorcycles, exciting activities, participating businesses and organizations, entertainment, great food featuring a pulled pork and best pizza contest, awesome prizes, and lots of outdoor fun.

I also want to inform you that there will be road closures associated with this event – **North Wayne Avenue between Lancaster & West Avenue AND a small portion of West Avenue.** Please see attached map of the event. Due to the footprint this event will entail, these areas will be closed between Lancaster Avenue and West Avenue as of 7:00 AM through 7:00 PM on the day of the event (with limited access) – Sunday, April 24, 2016 (Rain Date: Sunday, May 1, 2016). Parking will be prohibited in this area during the closure and vehicles will be towed.
