PUBLISHED COMMENTS

This was a change of ownership inspection. No food on site at time of initial inspection. Correct violation within 3 days, with the exception of splash guard, which should be corrected within 2 weeks. As of 2/21/19, Facility permitted to begin ordering and storing food but not permitted to prep food or open to the public at this time.

Follow up inspection:

02/25/19 10 am. Follow up inspection noted that cleaning violations have been corrected with the exception of residual grease on floor under the grill-needs cleaning prior to opening to the public in addition to the floor in the walk in refrigerator. Splash guard for hand sink has been ordered as per online invoice. Once received, install immediately.

AS of 2/25/19, Facility permitted to operate and open to the public.
