This letter confirms the action taken by the Radnor Township Board of Commissioners at their Monday, April 27, 2015 meeting. As a result of your request and presentation to install a berm on the Rye field from excess soils to be removed in connection with the Ardrossan subdivision, the Board of Commissioners approved a motion to authorize the installation of the berm as reflected in the plans and site line elevations you provided to the Township but not to release the \$40,000.00 escrow for additional plantings and/or trails.
