*2. Community Organizations Donations – Discussion and Direction*

There was discussion amongst Commissioners, topics included; sustainability of increasing annual contributions and receipt of less tax dollars; moving forward to meet with individual groups, beginning in January, to discuss funding for the next 5 years; cutting donations this year; cutting donations with the exception of Fire Companies and Library; look at cutting donations to organizations that are not municipal services.

Christi Seidel, President & CEO of Surrey Services – She spoke on cost cutting measures taken by Surrey Services, which included furlough of employees.

*3. Proposed Millage Rate for Board Discussion*

There was a discussion amongst the Commissioners, Solicitor, and Staff on the proposed millage rate and appeals.

*4. Ordinance #2020-22 – (Adoption) Adopting a Final Comprehensive budget for Fiscal Year 2021 and Establishing the Township Millage Rate in Accordance with the County Reassessment.*

Commissioner Larkin moved to amend the budget to add the Junior Engineer position, seconded by Commissioner Enderle. The motion passed 5-2 with Commissioners Abel and Booker opposed.

Commissioner Farhy moved to cut the donation to Surrey Services by 30%, seconded by Commissioner Abel. The motion passed 4-3 with Commissioners Borowski, Mulroney, and Enderle opposed.

Commissioner Abel moved to cap the Junior Engineer salary at \$50,000 seconded by Commissioner Booker. The motion failed 5-2 with Commissioners Abel and Booker in favor of cap.

Commissioner Larkin called the vote, the motion to Adopt Ordinance 2020-22 as amended passed 5-2, with Commissioners Abel and Booker against.

5. *Ordinance #2020-23 – (Adoption) Establishing the Township Sanitary Sewer Rate for 2021 at \$7.85 per 1,000 gallons of Water*

Commissioner Farhy noted that the rate is staying the same as the previous year.

Commissioner Larkin called the vote to Adopt Ordinance 2020-23. The vote passed 7-0.

6. *Ordinance #2020-24 – (Adoption) Amending Chapter 162 of the Township Code by Adopting the Consolidated Fee Schedule for Calendar Year 2021*

Commissioner Larkin called the vote to Adopt Ordinance 2020-24. The vote passed 7-0.
