***Minutes of the Organization Meeting of the Board of Commissioners of January 4, 2021***

*The Radnor Township Board of Commissioners met via Zoom at approximately 7:35 pm*

**1. Call to Order**

President Larkin called the meeting to order.

**2. Pledge of Allegiance**

President Larkin led the assembly in the Pledge of Allegiance

**3. Election of President**

Commissioner Borowski nominated Commissioner Larkin for President, seconded by Commissioner Mulroney

Commissioner Abel nominated Commissioner Booker as President, seconded by Commissioner Booker.

Commissioner Larkin called the vote for Commissioner Larkin as President, the motion passed 5-2 with Commissioners Booker and Farhy against.

**4. Election of Vice President**

Commissioner Enderle nominated Commissioner Mulroney for Vice President, seconded by Commissioner Larkin.

Due to an interruption in internet service Commissioner Borowski moved to go to recess, seconded by Commissioner Mulroney. The motion passed 4-3 with Commissioners Larkin, Booker, and Enderle disconnected.

The meeting restarted at 8:03 p.m. Commissioner Larkin moved to adjourn the Organization and Regular meetings until January 5, 2021 at 7:30 pm. The motion passed 7-0.

The Organization Meeting of the Board of Commissioners resumed on January 5, 2021 at 7:35 p.m.

Commissioner Larkin led the assembly in the Pledge of Allegiance

Commissioner Larkin asked for any additional nominations for Vice President. Commissioner Abel nominated Commissioner Booker for Vice President, seconded by Commissioner Booker. Commissioner Booker nominated Commissioner Farhy for Vice President, Commissioner Farhy declined the nomination.

Commissioner Larkin called the vote for Commissioner Mulrone for Vice President, the nomination passed 4-3 with Commissioners Booker, Abel, and Farhy against.

*5. Appointment of the Township Solicitor*

Commissioner Larkin nominated Grim Biehn & Thatcher for Township Solicitor, seconded by Commissioner Farhy. The nomination passed 5-2 with Commissioners Booker and Abel against.

*6. Appointment of Township Labor Attorney*

Commissioner Borowski nominated Joseph Rudolf of Clark Hill for Township Labor Attorney, seconded by Commissioner Larkin. The nomination passed 5-2 with Commissioners Booker and Abel against.

*7. Appointment of the Township Secretary and designation of an Assistant Secretary*

Commissioner Larkin moved to nominate William White, Township Manager, as Township Secretary and to allow him to designate the Assistant Secretary, seconded by Commissioner Enderle. The motion passed 7-0. William White, Township Manager, designated Peggy Hagan, as Assistant Secretary.

*8. Appointment of Vacancy Board Chairperson*

Commissioner Mulrone nominated Jannie K. Lau for Vacancy Board Chairperson, seconded by Commissioner Borowski. There was discussion amongst the Commissioners. Commissioner Larkin called the vote, the appointment of Jannie K. Lau to Vacancy Board Chairperson passed 5-2 with Commissioners Booker and Abel against.

*9. Reappointments to Boards and Commissions*

Commissioner Borowski moved to approve the reappointments, seconded by Commissioner Enderle. The reappointments, of Kurt McCabe, John Riccutti, Janes Quinn, James Dolan, Bob Mordeczko, Sarah Oaks, Matt Golas, and Missy Deck, passed 7-0. The reappointment of Richard Weitzman passed 6-1 with Commissioner Booker against.

Commissioner Borowski would like to make it a priority to revitalize the Citizens Communications Council. Members of the Council are frustrated with the lack of meetings and would like more participation. Commissioner Borowski, Commissioner Enderle, and Molly Gallagher, Staff Liaison, will work together to revitalize the Citizens Communications Council.

*10. Appointments to Boards & Commissions*
