

ORDINANCE NO. 2013-17

AN ORDINANCE OF RADNOR TOWNSHIP, DELAWARE COUNTY, PENNSYLVANIA, AMENDING THE CODE OF THE TOWNSHIP OF RADNOR, CHAPTER 270, VEHICLES AND TRAFFIC, REVISING SECTION 270-16 STOP INTERSECTIONS, REVISING SECTION 270-28 PARKING PROHIBITED AT ALL TIMES, REVISING SECTION 270-31 SPECIAL PURPOSE PARKING ZONES, REVISING SECTION 270-34 PARKING PERMIT ZONES, AND REVISING SECTION 270-57 PARKING METER ZONES ESTABLISHED.

The Board of Commissioners of the Township of Radnor does hereby ENACT and ORDAIN:

Section 1. Chapter 270, Vehicles and Traffic, §270-16 Stop intersections, is hereby amended by adding the following stop intersection:

Stop Sign on	Direction of Travel	At Intersection of
<u>Old Oaks Road</u>	<u>South</u>	<u>Buckingham Drive</u>

Section 2. Chapter 270, Vehicles and Traffic, §270-28 Parking prohibited at all times, is hereby amended by adding the following:

Name of Street	Side	Location
<u>Brookside Circle</u>	<u>South</u>	<u>Entire length</u>
<u>Radnor Street Road</u>	<u>West</u>	<u>From the corner of Aberdeen Avenue to a point 103 feet northerly for a distance of 4 feet</u>

Section 3. Chapter 270, Vehicles and Traffic, §270-31 Special purpose parking zones, is hereby amended adding the following street:

Name of Street	Side	Authorized Purpose or Vehicle	Location
<u>Garrett Avenue</u>	<u>West</u>	<u>Handicapped parking</u>	<u>Commencing in front of 38 Garrett Avenue in a southerly direction for a distance of 18 feet</u>

Section 4. Chapter 270, Vehicles and Traffic, §270-34 Permit parking zones, is hereby amended, as follows:

Street	Side	Hours	Location
<u>Louella Avenue</u>	<u>Northeast</u>	<u>8:00 A.M. – 4:00 P.M., school days only</u>	<u>From Midland Avenue to Windermere Avenue</u>
[Runnymede Avenue]	[South]	[8:00 A.M. – 4:00 P.M./Mon-Fri]	[From centerline of South Wayne Avenue to a point 376 feet westerly thereof]

Section 5. Chapter 270, Vehicles and Traffic, §270-57 Parking meter zones established, is hereby amended by revising the location for the meter zones as follows:

Name of Street	Side	Rate	Time Limit	Meters	Location
North Wayne Avenue	West	1 US Quarter per 15 minutes	15 minutes	2	[From a point 340 feet north of the northerly curblin e of Lancaster Avenue to a point 362 feet northerly thereof] <u>From the west side of North Wayne Avenue, being Meter Nos. NW45 and NW46</u>

Section 6. Repealer. All ordinances or parts of ordinances which are inconsistent herewith are hereby repealed.

Section 7. Severability. If any section, paragraph, subsection, clause or provision of this Ordinance shall be declared invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of this Ordinance as a whole or any part thereof other than that portion specifically declared invalid.


Section 8. Effective Date. This Ordinance shall become effective in accordance with the Home Rule Charter of Radnor Township.
