

**RESOLUTION NO. 2013-03
RADNOR TOWNSHIP**

**A RESOLUTION OF RADNOR TOWNSHIP, DELAWARE COUNTY,
PENNSYLVANIA. REVISING THE 2013 CONSOLIDATED FEE
SCHEDULE.**

WHEREAS, the Township of Radnor adopted Ordinance No. 2012-19, establishing Township fees and costs for calendar year 2013; and

WHEREAS, Ordinance No. 2012-19 permits the Consolidated Fee Schedule to be revised by subsequent resolution of the Board of Commissioners; and

WHEREAS, an analysis of the details within the 2013 Consolidated Fee Schedule has produced an administrative recommendation to revise the details within the schedule of fees for the indicated Parks and Recreation Areas on behalf of Recreation and Community Programming Department.


NOW, THEREFORE, it is hereby **RESOLVED** that the Board of Commissioners of Radnor Township hereby adopts the following revision to the 2013 Consolidated Fee Schedule:



Adult League Team Field Permit (softball, soccer baseball, etc.) [The above fee applies to programs that utilize both Township fields & School District Fields]</p> <p>Adult League Team Field Permit (softball, soccer baseball, etc.) [The above fee applies to all new requests with full seasonal usage at Township Fields]</p> <p>The fee above was previously referred to as: Adult Softball / Soccer Field [This fee was previously set under the assumption that these programs utilize both Township and School District Fields and was repealed in February 2012 by Resolution 2012-33. Picnic Area Rental (non-pavilion areas) – Change to: Picnic/Court/Park Area Rental [It is recommended that the Picnic Area Rental fee be extended to include Courts/Park Areas (non-athletic field areas) for permitting.</p>	<p>\$55 Resident \$75 Non-Resident/Companies</p>	<p>\$55 Resident \$75 Non-Resident/Companies</p>

Willows Weekday (Monday – Thursday) Rental: Non-Profit Rate [It is recommended that Non-Profit Rentals be extended to Monday to Sunday at the discretion of the Recreation Department and are within 90 days of booking date; there is no proposed fee change]</p>	<p>\$500 (Resident); \$600 (Non-Resident)</p>	<p>\$500 (Resident); \$600 (Non-Resident)</p>
<p>4. Radnor Activity Center Birthday Party – 2 hour party with event supervisor</p>	<p>No Approved Rate for 2013</p>	<p>\$275 (Resident); \$305 (Non-Resident)</p>
