PROPOSED LEGISLATION

TO: Radnor Township Board of Commissioners

LEGISLATIVE HISTORY: The Board of Commissioners Adopted the 2012 Operating and Capital Budget on December 12, 2011 via Ordinance 2011-26. The 2012 Capital Budget indicates \$9,600 for the replacement of a snow plow (Public Works – Streets & Highways (Group 6-2) 05-430-4830).

PURPOSE AND EXPLANATION: The Public Works Department is seeking to purchase one replacement snow plow. The plow proposed to be replaced is no longer functional. The Public Works Department wishes to purchase one plow from H.A. Dehart & Son, for \$8,258.00. The plow would be purchased via the State of Pennsylvania COSTARS contract #025-052, precluding the need for sealed bid.

IMPLEMENTATION SCHEDULE: 1.) Adoption of Resolution by the Board of Commissioners, 01/03/2012 2.) PWD to process an electronic purchase order on 01/04/2012 3.) Signed purchase order sent to distributor on 01/05/2012 4.) Receive plow within 1-3 days

FISCAL IMPACT: Funding for this project is provided in account #05-430-4830, which has a starting balance of \$9,300.

RECOMMENDED ACTION: After reviewing the quotation with the Supervisor of Mechanics, Richard Petrella, I recommend the Board of Commissioners adopt the resolution allowing the Public Works Department to purchase the plow outlined in the attached quotation.

MOVEMENT OF LEGISLATION: It is being requested that the Board approve the legislation for the purchase of one snow plow.


WHEREAS, the Public Works Department requests to purchase one snow plow


