

**RESOLUTION NO. 2012-122  
RADNOR TOWNSHIP**

**A RESOLUTION OF RADNOR TOWNSHIP, DELAWARE COUNTY,  
PENNSYLVANIA. REVISING THE 2012 CONSOLIDATED FEE  
SCHEDULE.**

*WHEREAS*, the Township of Radnor adopted Ordinance No. 2011-27, establishing Township fees and costs for calendar year 2012; and

*WHEREAS*, Ordinance No. 2011-27 permits the Consolidated Fee Schedule to be revised by subsequent resolution of the Board of Commissioners; and

*WHEREAS*, Ordinance No. 2012-33 revised the 2012 Consolidated Fee Schedule with a repeal of the following fees by subsequent resolution of the Board of Commissioners; and

*WHEREAS*, an analysis of the fees has produced an administrative recommendation to reestablish the schedule of fees to cover a portion of the costs for administration of field permitting on behalf of Recreation and Community Programming Department staff.

*NOW, THEREFORE*, it is hereby **RESOLVED** that the Board of Commissioners of Radnor Township hereby adopts the following revision to the 2012 Consolidated Fee Schedule:

These fees do not apply to the established Radnor Community Sports Organizations – Radnor Wayne Little League; Radnor Soccer Club; Radnor Boys Lacrosse; Radnor Girls Lacrosse.		
Athletic fields will be evaluated for permitted use at the discretion of the Recreation Department in cooperation with the Public Works Department.
