AGREEMENT

THIS AGREEMENT, by and between **DELAWARE COUNTY LODGE NO.**27, FRATERNAL ORDER OF POLICE, on behalf of the Police Officers of the TOWNSHIP OF RADNOR (hereinafter referred to as "Police") and the TOWNSHIP OF RADNOR (hereinafter referred to as "Township").

WITNESSETH:

WHEREAS, Act 111 of 1968 provides that settlement entered into as a result of collective bargaining shall be reduced to a written agreement; and

WHEREAS, the Police and Township have reached an agreement as to the terms and conditions of employment for the contract years beginning January 1, 2011 and ending December 31, 2013 and thereafter until a new agreement is reached.

NOW THEREFORE, the Police and Township set forth the following modifications to their existing collective bargaining agreement.

1. WAGES:

Each officer shall receive an across-the-board increase to his/her base salary of 0% on January 1, 2011; 3% on January 1, 2012; and an additional 2.5% on January 1, 2013.

2. PAST PRACTICES:

All other existing benefits not modified by this Agreement, including inter alia current wages and all medical benefits plans extended through the present providers of same, shall remain "as is".

IN WITNESS WHEREOF, the parties hereto, intending to be legally bound hereby, incorporate these terms into their existing agreement and set their hands and seals the dates herein indicated.
