Wednesday's DRB Meeting will be held in person in the Township Building in the Radnorshire Room at 6:00 p.m.

Attached is the DRB Agenda for October 13, 2021. Please read protocol operating procedures below.

Protocol Operating Procedures:

The new guidance includes:

- A recommendation that all people regardless of vaccination status wear a mask in public indoor settings in areas of <u>substantial or high transmission</u>. (Delaware County is now considered a county with substantial transmission.)
- Information that all people regardless of vaccination status wear a mask regardless of the level of transmission, if they are immunocompromised or at <u>increased risk for severe disease</u> from COVID-19, or if they have someone in their household who is immunocompromised, at increased risk of severe disease or not fully vaccinated.
- A recommendation that all people who have a known exposure to someone with suspected or confirmed COVID-19 to be tested 3-5 days after exposure, and to wear a mask in public indoor settings for 14 days or until they receive a negative test result.
- CDC recommends universal indoor masking for all teachers, staff, students, and visitors to schools, regardless of vaccination status
