- Discussion of the Proposed Lighting Ordinance
 - o Mr. Golas reviewed his findings from other local ordinances
 - o The board each gave their input for discussion
 - o All Board Members feel this is Incomprehensive and does not meet the needs of the township
 - o Mr. Kunda asked if there is sufficient language within the existing code to do enforcement.
 - o Mary Eberly, Esq does not think there is sufficient language within the existing code and feels it would be very difficult to enforce.
 - o Mr. Kunda Asked Counsel if the current ordinances permit the township to make an assessment that the lights are polluting the neighborhood do they have to be shielded, replaced or changed?
 - o Mary Eberly, Esq yes but says that it doesn't say how they have to fix it, just that they have to stop the light spillage.
 - o Mr. Kunda Can our Solicitor's office draft specific changes/amendments to our ordinance and not a replacement of the ordinance?
 - o Mary Eberly, Esq It is her opinion that that can be done.
 - o Mr. Falcone is concerned about taking the grandfather clause out
 - o Mr. Natt would like to see more focus on commercial and institutional rather than residential.

Public Comment -

- o Mr. Martin Caulfield 4 Hawthorne Lane- feels the issue is the pollution the lights are causing, not how long they are on.
- O Commissioner Farhy does not agree with the grandfather issue, agrees that it is not perfect but what can be use? What are some good aspects of this proposed ordinance where we can grow?
- o Jane Gallie, 7th Ward expressed her concerns about the lighting. She agrees that its an enforcement issue.
- o Anna Marie, Resident likes the concept of township wide. We should not single out specific areas.
