  - List of invasive trees proposed by James Gibbons
    - 1. Bradford pear/ Pyrus calleryana Ecological threat:
      - Naturalized callery pears compete with native early successional trees in old fields and hedgerows.
    - 2. Norway maple/ Acer platanoides
      - Ecological threat: This species is a frequent invader of urban and suburban forests. Its extreme shade tolerance allows it to penetrate deep within an intact forest canopy. Recent research has shown that forests invaded by Norway maple have less wildflower diversity compared with forests dominated by native Sugar maple (Acer saccharum).
    - 3. Tree of heaven/ Ailanthus antissima Ecological threat:
      - This tree produces chemicals in its roots that prevent the establishment of other plant species nearby. Its fast growth limits habitat for other species. Its root system may be extensive and has been known to cause damage to

sewer lines and building foundations. This species is a known host tree for the Spotted Laternfly.
