# 2018 Radnor Township Shade Tree Committee Goals – 2018 Year End Review

- 1) Implement the Master Street Tree Charter Matt & Eileen
  - a. Complete tree inventory as proposed in charter. -2600 street trees surveyed,  $\sim 40\%$  done (lowered from 50% based on survey of Radnor Trail).
  - b. Create a plan to address gaps. Gaps identified, and funds requested in 2019 budget proposal.
- 2) Keep the Ordinance Current and Effective Matt & Jack
  - a. Implement Recommended Tree List as an addendum for easy annual updating. DONE!
  - b. Implement Bamboo Ordinance.
    - i. BOC concerns are that the proposed ordinance is too restrictive (e.g. penalties, significant governance required to enforce, conflict with other ordinances regarding burning).
    - ii. With the BOC concerns in mind, next steps are to modify the ordinance as necessary, then present to BOC for approval in person providing the rationale for key aspects of the ordinance.
  - c. Help residents, developers and contractors follow the ordinance.
    - Since typically every month there is one property where the trees are already removed, before the STC is notified, consider increased enforcement and possibly a shade tree hot line for 2019. Also consider proactively working with contractors who aren't licensed in Radnor.
    - ii. When the Township does receive calls from residents or businesses, they typically respond within 1 hour per Steve Norcini.
  - d. New Goal Added for 2019: Update ordinance Joe
- 3) Serve our Residents via Proactive Communication James, Joe, Ginny
  - a. Increase Education and Awareness to help keep and improve Radnor's Tree Canopy
  - b. Increase awareness of why a tree canopy is valuable.
  - c. Make it easy to obtain advise on existing trees of concern to keep everyone safe.
  - d. Advise residents during construction projects on how to protect existing trees.
  - e. Make residents aware of the Spring and Fall tree giveaways.

    Communications were created and approved, awaiting Jim Dolan to update website.
- 4) Balance the Budget changed to "Manage Shade Tree Fund" in Oct2018 STC Meeting.
  - a. Obtain Grant Funds Jack identified the 1st grant. We'll target this more for 2019.

b. Provide estimates for anticipated expenses. - Done!
