Silt fence has been added and the trees have been identified as per the comments from the May meeting The canopies of the trees still need to be addressed in rough scale

The stormwater pipe will be moved to ensure that it is not placed within the drip line of any trees. No trees are slated to be removed on the plan but there are several that will be impacted. Revise the plan to indicated which trees will be removed and provide a tree replacement schedule.

The Landscape Architect will be contacted for further review

Utility easement is to be pushed to the east side to move farther away from roots of trees

Construction entrance to lot 2 through lot 1

Extend the tree protection fence around the 46" Ash

Septic area needs to be protected

36" Oak in area of pool should have tree protection fence as far as possible away from trunk of tree Applicant has agreed to supplement neighbors with additional buffering in locations to their satisfaction Grade lines will be moved away from the 24" Chestnut Tree

Drive way lines should be moved away from drip lines (root systems) of the trees

Demolition of the pool to be performed in such a way as to prevent any damage to the tree and stay away from the drip line of the tree and the roots will be pruned and fertilized accordingly

Note of the treatment of the roots to be placed on the plan

Replacement trees are already proposed to cover the large tree by the drive to lot 2 should it be damaged by construction of the driveway

Construction driveway up to lot 2 needs to be as far away as possible from the 47" Ash

Replanted tree species should be listed Plan is approved conditional on the revisions
