Moreover, any physical descriptions are based on victim and witness statements provided to the Radnor Police at the time the incident was reported or developed through investigation.

Dear Superintendent Flanagan,

In the early morning hours of Thursday, December 02, 2021, the Upper Darby Township Police Department requested outside assistance in response to a homicide that resulted in a shootout with SEPTA Police Officers. At the time of the call, Upper Darby officers were involved with another large-scale emergency.

Without delay, officers from the Haverford Township Police Department and Radnor Township Police Department responded to an apartment building, located at 7022 Terminal Square, Upper Darby Township, where they were advised by police dispatch that a shooting had occurred. The officers quickly gathered, formulated a plan, entered the apartment building, and cleared the occupied apartment. Once inside, the officers located a deceased shooting victim, as well as two additional residents, one of which was handicapped.

The officers professionally and efficiently secured the scene, separated the witnesses, relayed information, and stood guard until Upper Darby officers were able to take over. Once relieved, the officers, instead of clearing and returning to their districts, offered to stay and lend whatever help they could.

The response to and subsequent investigation of this incident was complex. The male suspect murdered his girlfriend inside an apartment, then proceeded onto a shooting spree, in which, over the course of three blocks, he shot another victim, shot at three bystanders, and exchanged gunfire with two police officers.

I want to offer a sincere "thank you" to you and your officers, not only for their timely response that morning but also for your continued support during times of need. Your officers are always there when needed most, and we can only hope to return the favor when the time comes.
