**A RESOLUTION OF RADNOR TOWNSHIP,
DELAWARE COUNTY, PENNSYLVANIA,
AUTHORIZING THE ACCEPTANCE OF CHANGE ORDER #5 BY
N. ABBONIZIO CONTRACTORS, INC. FOR THE ADDITION OF WINTERIZATION,
THREE INLETS WITH ASSOCIATED PIPING AND THE SOLAR LIGHTING SYSTEM; FOR THE
EXCLUSION OF BID ITEMS OF CLEAN IMPORTED BACKFILL, THE ORIGINAL LIGHTING
SYSTEM AND DISPOSAL OF CERTAIN FILL MATERIAL;
FOR VARIOUS QUANTITY ADJUSTMENTS AND FOR AN
ASSOCIATED TIME EXTENSION FOR THE
SOUTH WAYNE MUNICIPAL PARKING LOT FLOOD REDUCTION PROJECT
(CONTRACT #B-22-002) FOR THE TOTAL NET CREDIT AMOUNT OF \$379,492.26**

WHEREAS, N. Abbonizio Contractors has continued to work on the South Wayne Flood Reduction Project;

WHEREAS, Most recently additional changes were required for the project, including additional winterization, inlets and associated piping and solar lighting;

WHEREAS, Several bid items were no longer needed, including the original lighting system, imported backfill and an allowance for the disposal of fill which exceeds clean fill requirements;

WHEREAS, Adjustments in the quantities of the other bid items made throughout the project need to be addressed;

WHEREAS, The construction period has had to be adjusted to accommodate a variety of changes throughout the project; and


WHEREAS, N. Abbonizio Contractors has submitted an acceptable proposal as Change Order #5 for the needed changes.

NOW, THEREFORE, be it **RESOLVED** by the Board of Commissioners of Radnor Township does hereby Authorize the Acceptance of Change Order #5 by N. Abbonizio Contractors, Inc. for the Addition of Winterization, Three Inlets with Associated Piping and the Solar Lighting System; for the Exclusion of Bid Items of Clean Imported Backfill, the Original Lighting System and Disposal of Certain Fill Material; for Various Quantity Adjustments and for an Associated Time Extension for the South Wayne Municipal Parking Lot Flood Reduction Project (Contract #B-22-002) for the Total Net Credit Amount of \$379,492.26
