

**RADNOR TOWNSHIP PARKS & RECREATION DEPARTMENT  
VOLUNTEER RELEASE, HOLD HARMLESS AND INDEMNIFICATION AGREEMENT  
BACKGROUND CHECK AND CLEARANCE CONSENT**

I have agreed to serve as a volunteer for Radnor Township and I recognize that my volunteer participation is a privilege afforded to me by Radnor Township. I fully understand, appreciate and assume all the risks associated with my volunteer duties. In exchange for my participation, I hereby agree to the following:

1. To the fullest extent permitted by law, I shall indemnify, defend and hold Radnor Township and its elected or appointed officials, employees and authorized volunteers harmless from and against any and all claims, losses, damages, expenses, causes of action and liabilities (including without limitation, attorneys' fees) incurred in connection with any proceeding in which Radnor Township may be involved as a party arising out of my negligent acts, errors or omissions, or willful misconduct in providing services under this Agreement, unless such claims arise from the sole negligence or willful misconduct of Radnor Township. Such obligation to indemnify, defend and hold Radnor Township and its elected or appointed officials, employees and authorized volunteers harmless shall survive the termination of this Agreement.
2. The parties hereto agree and acknowledge that nothing contained herein shall be construed as or constitute a waiver of any immunity afforded Radnor Township or volunteer under the Pennsylvania Tort Claims Act, 42 Pa.C.S. "8501, *et seq.*, its successor statute or any other Federal or State law.

**BACKGROUND CHECK AND CLEARANCE CONSENT [As Applicable]**

I understand that, as part of the process to volunteer for Radnor Township under applicable circumstances I am required to submit to a background check and a child abuse history clearance check for the safety and well-being of those employed and attending recreation programs and community events. Therefore, I hereby agree to a mandatory background check and a child abuse history clearance check as a contingency of my volunteer status with Radnor Township. All information obtained as a result of a background check will be used solely for employment purposes.

I have read, fully understand and agree to the terms and conditions of the Volunteer Release, Hold Harmless and Indemnification Agreement and Background Check and Clearance Consent set forth above.
